NEW BUSINESS

1. Purchase of Real Property north of Pioneer Plaza – Mayor Maurer told property owner Keith Vaughn that the purchase of this property was discussed but that the City requests that the non-compete clause stating that the property cannot be used for the sale of hardware, ice cream, or candy for 40 years be stricken from the contract. Mr. Vaughn replied that he would need to check with his partners, but that he does not intend to remove that clause. His lawyer had suggested the 40 year time frame. Mr. Vaughn realizes this point may cause the closing date to be pushed back. He was agreeable to tabling this matter. There was a suggestion that the clause could be reworded with a sales percentage attached so that a business that sells hardware, ice cream or candy as a secondary product instead of a primary one could potentially locate on that lot.

Alderman Myers moved to table the purchase of Real Property north of Pioneer Plaza (North St); Alderman Naslund seconded the motion which passed by voice vote with no dissent.
