Michelle traveled to Fairview on February 5th to complete the form 471 requirement to continue to receive E-rate funds for phone and internet.

New Business: Doug Slaton made a motion to approve the Library Bill of Rights which is required to receive the per capita grant from the state of Illinois, and Kaarina Stanley seconded it. It was then unanimously approved by the board. Rae Slaton and Doug Slaton will not be present at the March 2024 meeting.
