AN ORDINANCE PROVIDING FOR ANNEXATION OF THE CONOVER PROPERTY (749 US HIGHWAY 150 E) TO THE CITY OF KNOXVILLE, KNOX COUNTY, ILLINOIS

WHEREAS, a petition signed and verified by Jonathan L. Conover and Biana Conover (the "Petitioners") has been filed with the City Clerk of the City of Knoxville, Knox County, Illinois ("City") pursuant to and in conformance with 65 ILCS 5/7-1-8 requesting annexation to the City of a certain tract of land hereinafter described (the "Territory"); and
