MINUTES

Call to Order: Mayor Myers called the Regular Council Meeting to order at 7:00 PM.

All rose to recite the **Pledge of Allegiance**.

Approval of Minutes: Alderman **Eiker moved** to approve the Minutes of the March 16, 2026, City Council Meeting. Alderman **Hillier seconded** the motion which **passed** by voice vote with one abstention (Hope).

1. **2026 Motor Fuel Tax Resolution Amended:** The Motor Fuel Tax Resolution approved at the March 16, 2026 Council meeting needed to increase the resolution amount from \$417,000.00 to \$495,000.00 due to probable oil price variance. Alderman **Hillier moved** to accept the 2026 Motor Fuel Tax Resolution for \$495,000.00. Alderman **Rainey seconded** the motion which **passed** with eight (8) Yes votes.

2. **Resolution 2026-07 Hire Full Time Police Officer Dashiel Loving:** Alderman **Hillier moved** accept Resolution 2026-07 to hire Full Time Police Officer Dashiel Loving at \$21.50 per hour. Alderman **Taylor seconded** motion which **passed** with eight (8) Yes votes.
3. **Resolution 2026-08 Hire Part Time Grounds Maintenance Worker Sakyas Whitman:** Alderman **Hillier moved** to accept Resolution 2026-08 to hire Part Time Grounds Maintenance Worker Sakyas Whitman at \$15.00 per hour. Alderman **Taylor seconded** the motion which **passed** with eight (8) Yes votes.
4. **Resolution 2026-09 Hire Part Time Grounds Maintenance Worker Zachary Shaw:** Alderman **Hillier moved** to accept Resolution 2026-08 to hire Part Time Grounds Maintenance Worker Zachary Shaw at \$15.00 per hour. Alderman **Taylor seconded** the motion which **passed** with eight (8) Yes votes.
5. **Resolution 2026-10 Aggregate Purchase of Electricity:** Rock River Energy Services is again working with several communities to combine to sign a municipal aggregation contract, since electric prices change daily. Alderman **Eiker moved** to approve Resolution 2025-10 – Aggregate Purchase of Electricity, granting the Mayor, or a designee, authority to approve a contract. Alderman **Hillier seconded** the motion which **passed** with eight (8) Yes votes.
6. **Adopt Return to Work Policy:** Mayor Myers explained that this policy is part of the handbook updating the return-to-work policy. Alderman **Hillier moved** to accept the Return-to-Work Policy. Alderman **Eiker seconded** the motion which **passed** with eight (8) Yes votes.
7. **Water Department Pumps and Motors:** Alderman Rainey stated that the initial bid for pumps and motors was \$17,056.40, whereas the most recent bid is \$22,604.80. Alderman **Hillier moved** to accept the current bid for the water pumps and motors for \$22,604.80. Alderman **Hope seconded** the motion which **passed** with eight (8) Yes votes.
8. **Police Starcom Radio Upgrade Quote:** Chief Poyner explained Star Com 21 radio system/ Homeland security upgrades. Chief Poyner stated that the Knoxville Police Department needed the upgrade to be able to communicate with the county officers due to the encryption and TDMA upgrade. Starcom 21 agreed to honor the original price of \$52,381.02. Alderman **Moore moved** to accept the Starcom Radio upgrade for the Knoxville Police Department. Alderman **Hillier seconded** the motion which **passed** with eight (8) Yes votes.

Mayor's Report:

- The city was able to identify two water leaks, one of which was substantial.
- The Easter Egg Hunt went well, thanks to Heather Hawkinson's organization.
