# Monday, December 18, 2023, 7:00 PM MINUTES

**Call to Order:** Mayor Myers called the regular Council Meeting to order at 7:00 PM.

All rose to recite the **Pledge of Allegiance.** 

**Roll Call: Present:** Aldermen Eiker, Gruner, Hillier, Hope, Moore, Rainey, Reed, and Taylor; Mayor Myers, Treasurer Barnum, Attorney McCoy, Chief Poyner, and City Clerk Wilt. **Absent:** None. Also present: Officer Zac Cox.

**Public Comments:** Clerk Wilt and Chief Poyner thanked the Council for their Christmas bonuses and the Christmas party. A card from employee Marilyn Greenfield was circulated, thanking the Council for the same items.

**Approval of Minutes:** Alderman **Gruner moved** to approve the Minutes of the December 4, 2023 City Council Meeting. Alderman **Hillier seconded** the motion which **passed** by voice vote with no dissent.

#### **OLD BUSINESS**

1. Review of Plumbing Work at 174 Northview Dr: As noted at the December 4, 2023 Council meeting, the homeowner wants the City to pay their plumbing bill for sewer back up from November 2023. Due to equipment constraints, Water Superintendent Johnson has been unable to televise this area again to determine if roots were causing sewer problems in the area, as the contracted plumber had stated. Alderman Gruner moved to pay Basio Plumbing Heating and Air Conditioning \$235.88 for plumbing work at 174 Northview Dr. Alderman Eiker seconded the motion, which passed with eight (8) Yes votes. Clerk Wilt, with Alderman Gruner, will draft a letter to Basio Plumbing to include

2. Demolition Bids for 209 N Hebard St: No new demolition bids that include asbestos removal for 209 N Hebard St have been received yet from either Gibbs Construction or Lockwood Excavating & Construction. Alderman Moore moved to accept the lowest demolition bid for 209 N Hebard St from the company that includes asbestos abatement without changing their bid. Alderman Hillier seconded the motion, which passed with eight (8) Yes votes.

- 1. Ordinance 2023-09 Tax Levy: As per discussion at the December 4, 2023 Administrative Committee meeting, a 2.5% increase was presented for the 2023-2024 tax levy. Alderman Hillier moved to approve Ordinance 2023-09 2023-2024 Tax Levy. Alderman Gruner seconded the motion, which passed with eight (8) Yes votes.
- 2. Zoning Board of Appeals TIF Request Knoxville Bar & Grill 310 E Main St:

The Zoning Board of Appeals reviewed and recommended approval of this request at their December 14, 2023 meeting. Alderman Gruner moved to approve the TIF request for Knoxville Bar & Grill, 310 E Main St. Alderman Eiker seconded the motion, which passed by voice vote with no dissent.

Zoning Board of Appeals -- TIF Request Beavers Teeth Axe Throwing, Brew & Chew 320 E Main St: Rafael Fuentes had submitted a TIF request for \$40,000.00 for flooring, painting, siding and parking lot improvements. The Zoning Board of Appeals reviewed and recommended approval of this request at their December 14, 2023 meeting. Alderman Moore moved to approve the TIF request for Beavers Teeth Axe Throwing, Brew and Chew 320 E Main St. Alderman Hillier seconded the motion, which passed by voice vote with no dissent.
- 4. Zoning Board of Appeals TIF Request Tim Eagle Market Street Mall 111 N
  Market Street: Tim Eagle had submitted a TIF request for \$40,000.00 for door, roof, parking lot and overhang improvements. The Zoning Board of Appeals reviewed and recommended approval of this request at their December 14, 2023 meeting. Alderman Hillier moved to approve the TIF request for Market Street Mall, 111 N Market St. Alderman Gruner seconded the motion, which passed by voice vote with no dissent.
