**Call to Order:** Mayor Myers called the Regular Council Meeting to order at 7:00 PM.

The increase of \$0.22 will take effect now, with the rate to automatically increase annually on June 1. Alderman **Rainey moved** to approve Ordinance 2025-04 Regarding Water Rates. Alderman **Taylor seconded** the motion which **passed** with six (6) Yes Votes and two (2) Absent.
2. **TIF Approval - Gary Goudie 302 East Main Street:** Alderman **Gruner moved** to approve the distribution of TIF funds for \$2,130.00 to Gary Goudie for 302 E Main St. Alderman **Hillier seconded** the motion which **passed** with six (6) Yes votes and two (2) Absent.
